Pursuant to Sections 617.1101, 617.1103, 617.1105 and 617.1106, Florida Statutes, the undersigned corporations affirm and adopt the following:

- 1) The Plan of Merger is attached hereto as Exhibit "A", and is fully included herein by reference.
- 2) The amendments to the Articles of Incorporation of the surviving corporation are attached hereto as Exhibit "B".
- 3) The Plan of Merger and the amendments to the Articles of Incorporation of the surviving corporation, as well as to the Articles of Incorporation of each merged corporation, were approved at meetings duly noticed and held on France 21 and 1996, by the affirmative votes of the Board of Directors of each such corporation, which votes are sufficient for adoption under Article X of the Articles of Incorporation of each such corporation.



Englewood Isles, Unit 4, Improvement Association, Inc. Englewood Isles, Unit 5, Improvement Association, Inc. Englewood Isles, Unit 6, Improvement Association, Inc.

- 2. The surviving corporation shall be Englewood Isles, Unit 4, Improvement Association, to be henceforth known as Englewood Isles Property Owners Association, Inc.
- 3. All assets and liabilities of the merged corporations shall become the assets and liabilities of the surviving corporation.
- 4. The Articles of Incorporation of the surviving corporation shall be amended as set forth in the attachment hereto.

ARTICLES OF INCORPORATION

ENGLEWOOD ISLES, UNIT 4, IMPROVEMENT ASSOCIATION, INC.

ARTICLE I.

NAME

The name of this corporation shall be Englewood Isles <u>Property</u>

<u>Owners, Unit 4, Imprevement Association</u>, Inc., and the same shall be located in the County of Sarasota, State of Florida. Said corporation shall hereafter be referred to herein as the "Association".

ARTICLE II

PURPOSE

The general nature, object and purpose of the Association are the following:

To protect and promote the property, health, safety and welfare of the owners all lots in of Lots 1 to 78 inclusive, Englewood Isles Subdivision, Unit 4; Englewood Isles Subdivision, Unit 5; and Englewood Isles Subdivision, Unit 6, as per the plats plat thereof, recorded in the Public Plat Book Page of the Official Records of Sarasota County, Florida. As used herein, "Subdivision" shall refer to all three such subdivisions collectively.

To provide, maintain and repair landscaping in the general and common areas, parks, sidewalks, access paths, and streets; to provide, maintain and repair common areas, structures, and improvements in the Subdivision.

To provide for utility services and other services for the common good of the owners of lots in the Subdivision.
